THE SERVICE FACILITIES NAMED HEREIN AND AS MAY BE REQUESTED FROM TIME TO TIME AND AGREES TO PAY ALL SERVICE FEES AND OTHER CHARGED IN ACCORDANCE WITH SAID RATES AND SERVICE REGULATIONS. IN CONSIDERATION OF THE SERVICE APPLICANT, SO FAR HE LEGALLY CAN GRANT A PERPETUAL RIGHT TO THE CITY OF PHENIX CITY, ALABAMA TO PLACE PIPES AND EQUIPMENT ON PREMISES OF APPLICANT TO SERVE SAID PREMISES AND/OR ADJACENT PROPERTY, UPON THE BEGINNING OF THE SERVICE APPLIED FOR HEREIN, OR WHICH MAY BE APPLIED FOR HEREAFTER THE APPLICATION BECOMES A CONTRACT UNTIL TERMINATED AS PROVIDED IN SAID SERVICE REGULATIONS. IT IS ALSO AGREED THAT THE "CONNECTION FEE" SHALL NOT BE REFUNDABLE AFTER THE CONNECTION HAS BEEN MADE. IT IS ALSO AGREED THAT THE UNDERSIGNED MAY TRANSFER SERVICE TO ANOTHER SERVICE ADDRESS WITHOUT POSTING ANOTHER CONNECTION FEE PROVIDED THAT THERE HAS NOT BEEN A BREAK IN SERVICE. IF THE SERVICE HAS BEEN DISCONNECTED FOR NON-PAYMENT OF A MONTHLY BILL OR A SERVICE CHARGE FEE AN ADDITIONAL CONNECTION FEE WILL BE REQUIRED. IF A FINAL BILL HAS BEEN RENDERED FOR ANY REASON A NEW SERVICE APPLICATION MAYBE REQUIRED AND WHEREAS ANOTHER CONNECTION FEE WILL BE REQUIRED.
