

RESOLUTION NO. 2016- 250

WHEREAS, a regular municipal election will be held on the 23rd day of August, 2016 and a runoff election, to be held, if necessary, on the 4th day of October, 2016; and

WHEREAS, Section 11-46-27 of the Alabama Code of 1975, as amended, and regulations adopted pursuant thereto provide, in part, that the municipal governing body, not less than 15 days before the holding of any municipal election, appoint from the municipality, officers to hold the election as follows: where electronic ballot counters are used, at least one inspector and three clerks.


