JOB SUMMARY

Under the direction of the Finance Director performs complex financial analysis and financial forecasting for the City. Manages municipal debt and investment activity, assists with the annual budget preparation. Performs and reviews routine accounting tasks, payroll administration, purchasing, revenue collection, and accounts payable and receivable functions.

ESSENTIAL JOB DUTIES/RESPONSIBILITIES

The following duties are normal for this position. The omission of specific statement of the duties does not exclude them from the classification if the work is similar, related, or a logical assignment for this position. Other duties may be required, assigned and expected aside from those set forth below to address operational needs and changing operational practices.

- Supervises and assists in the preparation of monthly financial reports and the annual external financial audit
- Reviews and assists in maintaining general and subsidiary ledgers
- Assists with reviewing bank account reconciliations and providing technical guidance to purchasing operations, payroll administration, accounts payable and account receivable process and cash management functions
- Assists in recording and accurately reporting capital assets
- Prepares intricate journal entries and assists in reviewing routine accounting transactions
- Reads and interprets contents of intergovernmental agreements
- Researches and collects data to ensure accurate accounting and reporting for grant administration
- Monitors compliance with generally accepted accounting principles and various City,

State and Federal regulations

- Conducts complex financial analysis
- Researches financial market and the economic environment and make recommendation for long-range financial planning and assists in preparation of the City's annual budget and related documents
- Supervises the City's banking activities and investment portfolio
- Prepares cash flow projections and monthly investment reports in accordance with the best practices and the City's guidelines and policies
- Possesses an in depth understanding of governmental finance and municipal debt to assist with municipal borrowing and capital expenditure planning
- Manages and maintains all warrants issued by the City to include appropriate accounting and reporting, debt repayment and statuses of planned projects funded with warrant funds
- Ensures that financial reporting is in accordance with GAAP and GASB standards, federal, state and municipal laws
- Researches and obtains a thorough understanding and knowledge of laws and best practices related to municipal debt and strategic financial planning
- Ensures processes and procedures are implemented and in place to promote effective financial operations and accurate and reliable financial reporting
- Serves as representative of the Finance Department in the absence of the Finance Director
- Maintain work area in an organized and neat manner
