If your bid is greater than \$10,000.00 a 5%, bond or cashier's check must accompany your bid. All sewer lines must be capped before being covered. All utility connections must be disconnected and secured. All debris and accumulation of materials resulting from demolition or any building shall be removed from the premises and disposed of properly. Grade lot to prevent standing of water.

Permanent Grassing Specifications:

A Spreader is required to distribute seed/fertilizer.

March 1 to August 31 – Common Bermuda grass (Hulled) 10 lbs/acre

September 1 to March 1 - Common Bermuda grass (Unhulled) 10 lbs/acre and Annual Ryegrass 10 lbs/acre Fertilizer Rate:

Nitrogen 5% - 10% 60 - 90 lbs/acre 120 - 180 lbs/acre Phosphorous 10% - 15% Potassium 10% - 15% 120 - 180 lbs/acre Mulch 1000 lbs/acre Lime 500 lbs/acre

All work shall be completed within thirty (30) days of the bid being let.

Payment, in full, shall be awarded after the completion of a final inspection. There will be no partial payments. All work shall be performed in compliance with Federal, State, and the International Building Code, 2018 Edition, Section 3303.
