RE: **Annual Transportation Plan Report** 

On March 12, 2019, the Alabama Legislature passed House Bill 2 which levied an additional excise tax on gasoline and diesel fuel (10 Cent Gas tax). This additional tax is to be used for maintenance, improvement, replacement and construction of roads and bridges that are maintained by the City. The Bill further stipulates that the City Engineer shall provide a written report detailing expenditures made from these monies during the previous year and include the status of the projects shown in the Annual Transportation Plan.

As of December 26, 2023, there is a balance of \$(290,770.43) in the 10 cent Gas Tax account. The City received \$354,608.61 from the additional ten (10) Cent Gas Tax in FY 2023. To date, the City has expended \$645,379.04 on the following projects; Preliminary Engineering and Construction costs for Project No. STPPC-5721(250) Resurfacing Various Streets in Phenix City and Project No. STPPC-5717(252) Replace the Bridge over Cochgalechee Creek on Seale Road. I have attached information provided by Finance to be included in the report.
