ADDENDUM NO. 1

PROJECT: UT 24-03 Collection and Disposal Services for Residential Garbage,

Trash, Recyclables, and Leaves

This Addendum forms a part of the Contract Documents and modifies the original Contract Documents as described. Each bidder shall acknowledge receipt of this addendum on the space provided on the bid forms.

- 1. Would the City consider amending the umbrella insurance coverage to be \$5M vs \$10M as the contract value is well under \$5M per year. Yes.
- 2. What are the current Contractor's rates for the services currently being provided. Please define the current level of service (Is it just the Base Service or is RCY, Trash, Leaves & Grasses part of the current service? Basic service: One cart, once per week is \$16.64, each additional cart is \$12.48. The remaining services are currently being provided by the City's Public Works Department.
- 3. Please provide the quantities (in tons if possible) of the following materials collected annually within the City as a result of the current Collection & Disposal **Services Contract:**
 - a. MSW

The City has requested this amount from its vendor and will supplement this addendum upon receipt.

b. RCY from Residential Units

c. RCY from the 3 City RCY Collection Sites

Currently the City operates two RCY collections sites, but would like to expand. Approximately 111.475 tons.

d. Trash

Currently trash, leaves, and grass are collected by the City's Public Works Department and it estimates approximately 2,054.39 tons are deposited in the City's inert landfill. An additional 15,988 cubic yards are deposited in a private landfill.

e. Household Hazardous Waste

The City has not conducted any hazardous waste collection events.

f. Leaves & Grass

See answer to (d) above.

4. Please confirm that all MSW collections from residents and/or small business must be contained with the hauler-provided 95-gallon cart and that overflow requires the rental of an additional cart and placement of waste within the cart for collection service.

Currently the City's ordinance does not require the MSW to be placed in an provided cart. However, the City intends to modify said ordinance to require all MSW to be placed in a provided cart.

5. Please provide a listing of all Rear Door Collection customers.

The City currently serves 57 rear door collection customers.

6. Please provide a copy of the current contractor's routing plan by days of the week and units per route.

The City's vendor has not provided this information, but the same has been requested.

7. Please provide a listing of "events" in which the City has traditional requested solid waste services. Please include the type and # of container required per event.

At this time there are no events for which the City has requested additional solid waste services.

8. Please provide the dates and locations of the last 2 Household Hazardous Waste Collection events including the HHW processor/subcontractor, list of acceptable items and the quantities collected.
