#### FEBRUARY 17, 2016 MEETING MINUTES

The members of the City Council of the City of Phenix City, Alabama met in a regularly scheduled meeting at 6:00 p.m. Eastern Time on Wednesday, February 17, 2016 in the Council Chambers located within the Public Safety Building at 1111 Broad Street, Phenix City, Alabama. Upon roll call the following members were present: Councilmember Johnny Barfield, Councilmember Gail N. Head, Councilmember Jim Cannon, and Mayor Eddie N. Lowe. Councilmember Arthur L. Day, Jr. was not present. Also present were City Manager Wallace B. Hunter, City Attorney James P. Graham, Jr. and City Clerk Charlotte Sierra.

There being a quorum established, Mayor Lowe called the meeting to order.

Reverend Ladaris Hood, Pastor of Bethlehem Missionary Baptist Church led the invocation.

Councilmember Barfield led the Pledge of Allegiance to the US Flag.

Mayor Lowe presented a proclamation recognizing retiring Assistant District Attorney Joe Edwards.

Joe Edwards and his wife came forward to accept the Proclamation.

Mayor Lowe presented for approval the minutes for the February 1, 2016 work session meeting minutes. Councilmember Cannon moved to approve the minutes, which motion was seconded by Councilmember Head. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Head, Cannon, and Mayor Lowe. NAYS: None. ABSTAIN: Barfield. The motion carried.

Mayor Lowe presented for approval the minutes for the February 2, 2016 council meeting minutes. Councilmember Head moved to approve the minutes, which motion was seconded by Councilmember Cannon. Upon said motion being put to a vote, the following vote

Mayor Lowe presented Itemized Statements of Expense from Steven Mathew Johnston, of the Fire Department, in the amounts of \$17.89 and \$14.07 which totals \$31.96. Councilmember Cannon moved to approve the expenses, which motion was seconded by Councilmember Barfield. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Head, Cannon, Barfield and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion carried.

Mayor Lowe presented an Itemized Statement of Expense from Ronald Reynolds, of the Engineering/Public Works Department, in the amount of \$10.00. Councilmember Head moved to approve the expense, which motion was seconded by Councilmember Barfield. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Head, Cannon, Barfield and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion carried.

City Attorney Jimmy Graham presented a claim filed by Deaven Shephard. City Attorney Graham advised the claim alleges that the City of Phenix City is responsible for damages to the claimant's 1996 Grand Marquis Mercury. The claim alleges that a City Trash Truck struck the vehicle while changing lanes on Downing Drive, located inside the Industrial Park, on January 24, 2016; the vehicle driven by the claimant's brother, Keyon Clancy. City Attorney Jimmy Graham's recommendation is to approve the claim in the lowest estimate of \$1,483.56. Councilmember Barfield moved to take the city attorney's recommendation to pay the lowest estimate of \$1,483.56, which motion was seconded by Councilmember Cannon. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Head, Cannon, Barfield and Mayor Lowe. NAYS: None. ABSTAIN: None. The motion carried.

City Attorney Jimmy Graham presented a claim filed by Attorney Fred Gray, Jr. on behalf of Tiffany McClain against the Phenix City Police Department. City Attorney Graham advised that the officer was off duty and was working under an independent contractor for Piggly Wiggly Stores. City Attorney Graham advised that based on the fact that the Police Officer was off duty, the city is not liable. City Attorney Graham's recommendation is to deny the claim. Councilmember Cannon moved to take the city attorney's recommendation to deny the claim, which motion was seconded by Councilmember Head. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Head, Cannon, Barfield and Mayor Lowe. NAYS: None. ABSTAIN: None. The motion carried.

City Attorney Jimmy Graham presented a claim filed by Jewel Styles. City Attorney Graham advised that Ms. Jewel Styles alleges that the city is responsible for damages to her rental property at 2324 Delbrock Drive. City Attorney Graham stated that our law enforcement had a warrant to search the premises. City Attorney Graham further stated the Police Department kicked the door in; however the owner of the property was not notified and could have been identified and contacted prior to the officer's executing the search warrant. City Attorney Jimmy Graham's recommendation is to pay the lowest estimate in the amount of \$792.00. Councilmember Barfield moved to take the city attorney's recommendation to pay the lowest estimate of \$792.00, which motion was seconded by Councilmember Cannon. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Head, Cannon, Barfield and Mayor Lowe. NAYS: None. ABSTAIN: None. The motion carried.

Mayor Lowe presented Resolution No. 2016-36 to be ratified in reference to authorizing and directing the Mayor and City Manager to sign Change Order Number One with Robinson Paving Company, Inc. for intersection improvements at Riverchase Drive and Summerville Road in an amount not to exceed \$57,376.50.
