# MEETING MINUTES June 19, 2018

The members of the City Council of the City of Phenix City, Alabama met in a regularly scheduled council meeting on Tuesday, June 19, 2018 at 6:00 p.m. in the Gymnasium of the 5<sup>th</sup> Street South Youth Center located at 1601 5th Street South, Phenix City, Alabama. Upon roll call, the following members of Council were present: Councilmember Arthur L. Day, Jr., Councilmember Vickey Carter Johnson, Councilmember Steve Bailey, Councilmember R. Griff Gordy, and Mayor Eddie N. Lowe. Also present were City Manager Wallace B. Hunter, City Attorney James P. Graham, Jr., and City Clerk Melony Lee.

Upon a guorum being established, Mayor Lowe called the meeting to order.

Reverend Alan Griffith with Emmanuel Baptist Church delivered the invocation.

Councilmember Gordy led the pledge of allegiance to the United States Flag.

Mayor Lowe presented the minutes of the June 4, 2018 work session and June 5, 2018 council meeting for approval. Councilmember Gordy moved to approve the minutes, which motion was seconded by Councilmember Johnson. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Johnson, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAIN: Councilmember Day. The motion carried.

Mayor Lowe stated there was no unfinished business to address at this time.

Mayor Lowe presented a resolution in reference to granting employees an additional half day for the observance of the Independence Day Holiday for 2018.

Mayor Lowe presented for the second reading an application for an Off Premise Whiskey/Wine License (Retail Package Store) submitted by Ghanashyam K. Patel for Shiv Shakti Food, LLC d/b/a Shakti Package Store located at 3858 Highway 80 West, Unit C, Phenix City, Alabama. Councilmember Gordy moved to approve the application, which motion was seconded by Councilmember Day. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Day, Johnson, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion carried.

Councilmember Day reminded the citizens that each district would hold a meeting in their district and would like for everyone in the community to know how the city government functions.

Councilmember Gordy advised the citizens that the Central Activities Center is still under construction and that is the reason for the changes in location of activities.
