## November 10, 2020

The Planning Commission of the City of Phenix City, Alabama met on Tuesday, November 10, 2020 at 5:15 PM EST in the Phenix City Council Chambers located in the Public Safety Building, 1111 Broad Street or via Zoom or by teleconference.

Chairman Howard called the meeting to order and asked Secretary Phillips to call roll. Upon roll call, the following members answered present: Vice Chairman Davis, Chairman Howard, Member Ivy, Member Lindsey, Member Sims, and Member Phillips. The second item on the agenda was the Oath of Office for Councilmember Vickey Carter Johnson. Ms. Johnson read the Oath of Office as follows:
