WORK SESSION MEETING MINUTES December 3, 2018

The members of the City Council of the City of Phenix City, Alabama met at 3:00 p.m. Eastern Time for the regularly scheduled work session on Monday, December 3, 2018, in the third floor conference room of the Municipal Building located at 601 12th Street, Phenix City, Alabama. Upon roll call, the following members were present: Councilmember Arthur L. Day Jr., Councilmember Vickey Carter Johnson, Councilmember Steve Bailey, Councilmember R. Griff Gordy, and Mayor Eddie N. Lowe. Also present were City Manager Wallace B. Hunter, City Clerk Melony Lee, and City Attorney Jimmy Graham. Department Heads in attendance were: Deputy Building Official Ray Rogers, Economic Development Manager Shaun Culligan, Engineering Director Angel Moore, Fire Chief Kris Kennedy, IT Director Mike Bauer, Library Director Michele Kilday, Municipal Court Clerk Ruby White, Parks and Recreation Director Todd Hughes, Human Resources Director Stephanie Chastain, Chief of Police R. Upon a quorum being established, Mayor Lowe called the meeting to order.

The invocation was led by Councilmember Gordy.

Mayor Lowe called upon Era Bowden and David Quinney to address council as listed on the agenda. Ms. Bowden presented a request for a street light to be installed at 2722 Summerville Place, Phenix City, Alabama. Mr. Quinney requested the street light to discourage criminal activity and he asked that the City pay for it monthly. Mayor Lowe advised that the city ordinance in place does not allow a street light to be placed less than 300 feet apart. The placement of street light does not meet the minimum requirement of the ordinance. The City has to be consistent with their decisions in such matters. City Manager Wallace Hunter advised that the homeowner's association would be the ones to pay for the street light. Mayor Lowe thanked Era Bowden and David Quinney for coming to speak with Council.

Mayor Lowe called upon Engineering Director Angel Moore to discuss the actions taken by the Planning Commission at their November 27, 2018 meeting.

Mayor Lowe called upon City Clerk Melony Lee who discussed the following with Mayor and Council:

Mayor and Council discussed the following:

- 2. Councilmember Johnson requested an update on the Central Activities Center. Parks and Recreation Director Todd Hughes advised the A/C repair was complete and hoping to reopen around the first of the year.
- 3. Councilmember Day thanked the Public Works Department for the work around the Industrial Park and state that the resurfacing of the road project and area around the Southside looks good.
- 4. Councilmember Bailey spoke on how nice the Christmas decorations and lights around the downtown area look. Councilmember Bailey also spoke on the Municipal Building lights looking very nice. Councilmember Bailey stated the Christmas parade had a very good turnout and was enjoyed by everyone.
