City Attorney Jimmy Graham reviewed the claims with Council.

City Manager Wallace Hunter stated that the City has always been fair and consistent in policies, procedures and decision making. Mr. Hunter also stated that there are rumors going around the City stating that the City has been unfair and that is not the case, City Leaders are simply doing their jobs and doing what is right. Mr. Hunter further stated that the City no longer operates under the "Good Ole Boy" System where certain people are treated a certain way because of their economic status. Councilmember Bailey stated that no one is above the law and everyone is treated equal.

Mayor Lowe stated that Phenix City won the court case regarding the distribution of gasoline tax proceeds against Russell County. Mayor Lowe also stated that in the declaration it states that payments should start immediately but he has not heard that they have started as of now. City Manager Wallace Hunter stated that he will be meeting with the County Administrator to discuss the payments.
